# Cultural Safety

Cultural safety: an environment that is spiritually, socially and emotionally safe, as well as physically safe for people; where there is no assault, challenge or denial of their identity, of who they are and what they need. It is about shared respect, shared meaning, shared knowledge and experience of learning together (Williams, 1999, p. 213).

## Thematic Analysis is a method

- An umbrella term 'thematic analysis'
- Clarke & Braun (2018) suggest two definitions of what is a theme-bucket and storybook

## In this activity

- We value flexible processes, articulate and understand our own subjectivity rather than seeing subjectivity as bias and as a problem to be managed.
- We will value open ended exploration and reflexivity

## What are themes and how do you find them?

- A theme is a pattern of meaning- described in music scores and sociological studies since the 1940's
- Using coding and a repeating processes of constantly reviewing data and how you have coded it, themes are where you end up rather than where you start

# Phases of Thematic Analysis (Clarke and Braun 2006)

- 1. Familiarise yourselves with the data and ideas of potential interest
- 2. Generate codes
- 3. Generate initial themes
- 4. Review initial themes
- 5. Refine and name 3 themes
- 6. Produce a statement which discusses the themes as findings.

## Co-Production

Processes are used in the design, implementation, and dissemination of research and knowledge products that involve people who use or are affected by the research or policy outcomes.

### Co-Production

- Transparent and inclusive about final products not only consultative and collaborative in design
- Timelines- can do because we now have February 2020 for final report
- Content and Process to be decided with CALD PAR participation

## Sharing Findings- Co-Production Principles

- Use of `co-design' processes in the design of research and knowledge.
- Services and products that involve people who use or are affected by the research or policy outcomes.
- Combines lived experience and professional expertise
- The communities your projects work with and you are the experts of those communities and projects
- Authenticity counts- successes and challenges
- Knowledge about prevention and pathways practice is best informed by local practitioners
- Involve people who use or are affected by the research or policy outcomes in production of resources/policy/practice and their review.

## Who do CALD PAR work with and for?

### 26 projects

Communities Leading Prevention: 18 (70%) Safer Pathways for CALD Women: 8 (30%)

**Gender** 60% mixed gender, 20 % men 20 % women **Locations** ACT – 1 QLD – 5 WA – 1 SA – 2 NSW – 7 VIC – 10

Majority are Working with CALD group/s and mainstream organisations, over 30 cultures/nationalities are mentioned across your activity work plans with 46% working with multiple cultural groups
